The report relates to³:

- a violation that qualifies as a criminal offence;

- a breach of Act No. 171/2023 Coll., on the protection of whistleblowers, as amended;
- a breach of any other European Union law or regulation in the field of:

 - corporate income tax;
 - prevention of money laundering and terrorist financing;
 - consumer protection;
 - product safety and compliance;
 - transport, traffic, and road safety;
 - protection of the environment;
 - food and feed safety and the animal health and welfare;
 - radiation protection and nuclear safety;
 - economic competition, public auctions, and public procurement;
 - protection of public order, internal order and security, life, and public health;
 - protection of privacy, personal data, and security of network and information systems;
 - protection of the EU's financial interests;
 - breaches relating to the internal market, incl. the protection of economic competition and state aid under EU law.
